CLI PROVIDES WORKSHOPS, INDIVIDUAL COACHING AND TENS OF THOUSANDS OF CHILDREN'S BOOKS TO OVER 2,100 TEACHERS IN 223 SCHOOLS ACROSS THE COUNTRY. IN ADDITION TO \$16.3M IN FEE-FOR-SERVICE REVENUE, CLI RELIES ON BOTH PHILANTHROPIC AND FEDERAL FUNDING, BRINGING TOTAL REVENUE TO \$24.7M.
