CLI PROVIDES WORKSHOPS, INDIVIDUAL COACHING AND TENS OF THOUSANDS OF CHILDREN'S BOOKS TO OVER 3,600 TEACHERS IN 345 SCHOOLS ACROSS THE COUNTRY. IN ADDITION TO \$24.1M IN FEE-FOR-SERVICE REVENUE, CLI RELIES ON BOTH PHILANTHROPIC AND FEDERAL FUNDING, BRINGING TOTAL REVENUE TO \$33.7M.
